

## **Privacy Policy**

Protecting your private information is our priority. This Statement of Privacy applies to [www.pepperminttransit.com](http://www.pepperminttransit.com) and PepperMint Transit LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to PepperMint Transit LLC include [www.pepperminttransit.com](http://www.pepperminttransit.com) and Pep Transit. The Pep Transit website is a Information and Ecommerce site. By using the Pep Transit website, you consent to the data practices described in this statement.

### **Collection of your Personal Information**

If you purchase Pep Transit's products and services, we collect billing and credit card information. This information is used to complete the purchase transaction.

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services available on the Site. These may include: (a) registering for an account on our Site; (b) entering a sweepstakes or contest sponsored by us or one of our partners; (c) signing up for special offers from selected third parties; (d) sending us an email message; (e) submitting your credit card or other payment information when ordering and purchasing products and services on our Site. To wit, we will use your information for, but not limited to, communicating with you in relation to services and/or products you have requested from us. We also may gather additional personal or non-personal information in the future.

### **Use of your Personal Information**

### **Sharing Information with Third Parties**

Pep Transit does not sell, rent or lease its customer lists to third parties.

All such third parties are prohibited from using your personal information except to provide these services to Pep Transit, and they are required to maintain the confidentiality of your information.
